In light of above sponsorship, you are requested to submit your sealed tender in a master envelope by mentioning "**Tender for Security Guards at CW.ISANPUR**", containing two separate sealed envelopes one superscribed as "**Technical Bid**" and other as "**Price Bid**" addressed to Regional Manager, Central Warehousing Corporation, Regional Office, Opp. Unnati Vidhyalay, Near Mahalaxmi Char Rasta, Paldi, Ahmedabad-380 007 on or before **15:00 Hours on 25.08.2021**. The price bid date will be intimated later.

**[I]** The documents to be attached with Technical Bid for the purpose of general assessment are as follows:-

- Copy of DGR Empanelment Certificate.
- Copy of DGR Sponsorship letter for CWC.
- License of Operation in the state of operation for the Security Agency if available otherwise documentary proof for having applied to the concerned state authority for license or undertaking for presenting the same before signing the contract. **(PSARA License)**.
- PAN card.
- Copy of Shops and Establishment Certificate.
- Copy of Goods & Service Tax Registration-GST Certificate.
- Copy of PF Certificate.
- Copy of ESI Certificate.
- Copy of draft agreement duly signed on each page as acceptance of the terms and conditions of the proposed contract for the work under reference (as enclosed).
- Bank Account details
- Rest of the terms and conditions mentioned in DGR sponsorship letter will apply.

Note:- Although absence of (d) to (k) above shall not bar the intending DGR sponsored agency as technically unfit, being a DGR sponsored agency, however furnishing information on these accounts are desirable for general assessment by CWC.

The Price Bid should consist about the **percentage of service charges**, which you wish to charge/levy from CWC in the format attached as **Annexure-II**. The price bid date will be intimated later.

The Price Bid shall be opened in the presence of security agencies Proprietor. The work award may be considered to the qualified agency, which shall quote the lowest rate of services charges.

In the event of a tie regarding service charges quoted between more than one agency, the criteria for evaluation of L-1 in such situation shall be based on the following guidelines of DGR which provide.

*"In case all the agencies sponsored to an employer quoted same rates in their tender, then the employer should award the contract to the **senior most agency** as mentioned in the DGR sponsored letter above subject to his satisfactory performance in the past. However, the principal employer may refer this case to the DGR for advice if required."*

Last date and time of receiving the tender is **25.08.2021** upto **15:00 hours** at Regional Office, CWC, Ahmedabad. Further, the **Technical bid** of the security agencies who submitted requisite **documents under Sr. No.[I] (a) to (c), which are mandatory** to be submitted, shall be opened on **15:30 hours** on the same day i.e. **25.08.2021**. Non-submission of these documents shall entail rejection of the offer of the concerned sponsored security agency participating in the process of submission of bid and not fulfilling this requirement.

Further, if the date fixed for opening of tender is declared holiday, the tenders will be opened on the next working day following the holiday at the same time.


